**7. UNFINISHED BUSINESS**

a. Cornerstone Development

The Site Plan Committee visited the site and had some discussion with the Cornerstone developers regarding their vision. They would like to revisit this with the Planning Commission. Mr. Finkbeiner and Ms. Denton visited the site and reported on its progress. Both of them stated that it is a beautiful site and would be a desirable location.

Tim Woodhams and Rich Rosenberger, speaking for Cornerstone Development, are present. Mr. Woodhams states that the work of marking plots and roads began last year after a misunderstanding regarding approval from the PC. They are now requesting a SEU permit for the project to proceed, as it will impact the size and location of lots, homes, pools, etc.

Mr. Kilgore states that he is relying on the input from the Township attorney stating facts about applications and site plans (Zoning Article 20.6). The site plan as presented does not comply with the minimum provisions of the zoning district.

Questions were raised about open space condo development, private and public roads, size of the lots, etc. Ms. Gasper states that she trusts the township attorney with his guidance and agrees with his input on this. Mr. Finkbeiner adds that he feels Thornapple Township is ripe for bigger lots and higher end homes.

Mr. Rosenberger states that he wishes for a way for them to work together with the township. Changing to 1.5 acre lots will force major changes in design of the roadway, home locations, trees, etc. Every lot is currently opened up and ready for construction. They are looking for a path forward where everyone can work together.

Mr. Kilgore stated that he will have another conversation with the township attorney regarding this.

**8. COMMITTEE REPORTS:**

- a. **Ordinance Committee** (Kilgore, Finkbeiner, Rairigh, Gasper (alt): The work of getting the ordinance cleaned up is going well. A question was raised about the potential for a Data Center in Thornapple Township. The question has been asked and it has been noted that Thornapple Township does not have the infrastructure for it.
- b. **Site Plan Committee** (Finkbeiner, Denton, Wandrie, Hansson (alt): Working on the site plan issues discussed above in Agenda Item #7.



- c. **Joint Planning Committee** (Rairigh, Gasper, Denton, Kilgore (alt): Working on getting a date to meet with the Village.

**9. ADMINISTRATOR'S REPORT:**

- a. Zoning Ordinance Audit - the Committee should meet for review of some ordinances.
- b. Zoning Report - was attached to the agenda.
- c. Code Enforcement Report - Log included in meeting packet.

**10. COMMISSIONER COMMENTS:**

- Two things in December included the Corners' remodel that was addressed here tonight and another application. In the future Mr. Gensterblum will send these applications to Mr. Kilgore for the Planning Commission.

- The swearing-in of PC members will take place during the February meeting by the Township Clerk.
